## August 28, 2018

The Dickinson City Council met in a duly called and announced **REGULAR MEETING** on **Tuesday, August 28, 2018,** at **7:00 p.m.** The meeting was held in the City Council Chambers located at 4403 Highway 3, Dickinson, Galveston County, Texas, and was held for the purpose of considering the following items:

## ITEM 1.) CALL TO ORDER

Mayor Masters called the meeting to order at 7:08 p.m.

## ITEM 2.) INVOCATION

Council Member King gave the invocation.

## ITEM 3.) PLEDGE OF ALLEGIANCE

Council Member Henderson led the Pledge of Allegiance.

# ITEM 4.) ROLL CALL

Deputy City Secretary Gabrielle Bernal called roll and certified a quorum. Council Members present were as follows: Mayor Julie Masters, Mayor Pro-Tem Wally Deats, and Council Members Charles Suderman, Bruce Henderson, Walter Wilson, Louis Decker, and William H. King, III. Also present were City Administrator Chris Heard, Assistant City Administrator/Chief Financial Officer Stephanie Russell, City Attorney David Olson, Director of Community Development Zachary Meadows, Director of Public Works Bryan Milward, and Police Chief Ron Morales. City Secretary Alun Thomas was absent.

## ITEM 5.) PROCLAMATIONS AND ANNOUNCEMENTS:

Mayor Masters read and presented the Proclamation.

- B. Announcements.
  - a. Council Comments.
    - Welcome and thank you to all for attending the meeting.

- The next "Coffee with the Chief" event will be held on September 4.
- "Meet the Teacher" nights are approaching, please be careful while driving due to the increased number of children in the area.
- Everyone is encouraged to thoroughly research potential contractors before giving them money, as many people scam others during disaster recovery.
- Thank you to City Administrator Chris Heard for attending and speaking at the First United Methodist Church's Hurricane Harvey anniversary event.
- Please contact Jack at First United Methodist Church if you would like to volunteer to help people recover from Hurricane Harvey.
- Thank you to City Administrator Chris Heard for facilitating the repair of the railroad crossing on FM 517.
- Installation of traffic lights at FM 517 and Rau Drive has now been completed.
- Hurricane Harvey was a humbling experience, and the City is working to help those affected, including by staff working with outside entities. The City is still waiting on some funding.
- The State of Texas is working on laws that would limit local control in the state, which would be to our City's detriment.
- The next Knights of Columbus fish fry will be held on September 7. Everyone is invited to attend.
- True Cross schools have reopened after making repairs from Hurricane Harvey. Thank you to Father Larry for his commitment and leadership during the rebuilding efforts.
- The Festival of Lights is seeking volunteers to assist with the Festival this year.

There was not a quorum for the August 21 Planning Committee meeting, but the members present discussed the financial report and education improvements. Also discussed was hurricane recovery funding; Dickinson remains first on the list of recipients for others' unexpended funds.

c. Update on Activities of the Dickinson Bayou Watershed Partnership (Council Member Decker).

There was not a quorum for the August 20 meeting, for the fourth meeting in a row. Some members, such as Alvin and Manvel, never attend the meetings. Those present discussed the need for detention ponds, and not just additional waterflow into Dickinson Bayou. Council Member Deats posed questions about the organization's charter and authority.

d. Update on Activities of the Dickinson Economic Development Corporation (Director of Economic Development Angela Forbes).

Ms. Forbes was not present at the meeting, so this item was not discussed.

e. Update of Public Works Projects (Bryan Milward).

Director of Public Works Bryan Milward provided an update to Council, and addressed questions concerning project timelines and project engineering.

ITEM 8.) CONSIDERATION AND POSSIBLE ACTION CONCERNING: Resolution 1692-2018 – A RESOLUTION OF THE CITY OF DICKINSON, TEXAS, WAIVING THE DRAINAGE CHARGES UNDER THE MUNICIPAL DRAINAGE UTILITY SYSTEM FOR THE 2018 CALENDAR YEAR; PROVIDING FOR THE INCORPORATION OF PREAMBLE; AND PROVIDING AN EFFECTIVE DATE.

Council discussed the drainage fee, and its low collection rate of approximately 53%. Council Member Wilson expressed concerns about waiving the fee, given that next year's tax rate has yet to be adopted. City Administrator Chris Heard reminded Council that the waiver proposed under this Item would only be for the 2018 calendar year.

Council Member Henderson made a motion to approve the resolution, and Council Member Suderman seconded the motion. There being no further discussion, Mayor Masters called for the vote.

ITEM 9.) CONSIDERATION AND POSSIBLE ACTION CONCERNING: Setting a Date for a Public Hearing to Consider a Proposed Ordinance to Abandon the Municipal Drainage Utility System.

Assistant City Administrator/Chief Financial Officer Stephanie Russell presented the item, and discussed the billing cycle for the drainage fee, which is billed by calendar year and not by fiscal year. Ms. Russell noted that the date for the public hearing would have to allow the City time to post a 30 day notice of the hearing. After a brief discussion, Council Member King made a motion to set the public hearing date as October 9,

2018, and Council Member Wilson seconded the motion. There being no further discussion, Mayor Masters called for the vote.

(First of Three Readings)

Council discussed the proposed ordinance, including whether the order of the agenda should be prescribed through codification or should allow for the City to have more flexibility in how the agenda is arranged. Council Member Suderman expressed his concern at removing the subsection and effectively leaving a blank hole in the City's Code of Ordinances.

Council Member King made a motion to approve the first reading of the ordinance, and Council Member Decker seconded the motion. There being no further discussion, Mayor Masters called for the vote.

Council discussed the proposed hydrological study, with Council Member Wilson expressing his concerns about the soundness of spending money on studies for unfunded projects. City Administrator Chris Heard informed Council that the study would help the City be proactive in addressing flooding concerns, and for standard maintenance, projects, and proposals.

Greg Wine, Senior Vice President of Huitt-Zollars, Inc. addressed questions regarding the City's drainage system capacity, noting that the system must handle more than just the conveyance of water to Dickinson Bayou. The main outcome of the proposed project is the identification of projects that could be completed to improve the drainage system. Mr. Heard said that any projects identified through the study would be brought to Council separately, and he ultimately would be responsible for project management. Council Member King expressed his approval for the resolution, given that the City must work quickly to present projects to the General Land Office for funding.

Council Member Decker made a motion to approve the resolution, and Council Member Henderson seconded the motion. There being no further discussion, Mayor Masters called for the vote.
